

Orders issued against this Request for Agency Catalog (RFAC) are subject to the provisions and clauses included in the underlying National Aeronautics and Space Administration (NASA) Solutions for Enterprise-Wide Procurement (SEWP) Agreement and the additional Federal Acquisition Regulation (FAR) and Defense Federal Acquisition Regulation Supplement (DFARS) clauses listed below that are incorporated in this RFAC. Ordering Offices should consider the requirements of DFARS and the FAR supplement of the end user component, as it applies to commercial item acquisition and use of NASA SEWP Catalog, in determining what additional clauses may be required for incorporation in the order issued by the Ordering Office.
